Rate 1 – Single and multiphase service to customers with 75 kVA transformer capacity or less.

Rate 3 – Seasonal Service to customers with over 75 kVA transformer capacity. On peak demand cannot exceed 25 kW from December 1 to March 1 of each winter.

Rate 4 – Interruptible service to customers with at least 25 kVA transformer capacity and standby generation capable of supplying total electrical requirements over control periods. (Off peak electric heating is metered separately and is charged at the standard off peak heating rate.)

“Standby” Service - \$13.00 per month to retain a de-energized service.

Minimum Charges - On new services with over 100 kVA transformer capacity, a monthly or annual “minimum” charge may be set.

Controlled Water Heater Credit - \$7.00 per month per structure on January thru April bills.

Rate “S” – Short Term Interruptible Off-Peak Heating (load groups 1.01 and 1.02)

Rate “L” – Long and Medium Term Interruptible Off-Peak Heating (load groups 2.01, 3.01, 3.09)

Rate “H” – Long Term Interruptible service to air-to-air heat pumps. This rate applies to metered energy billed in October thru June, the normal heating season.

OFF PEAK ELECTRIC HEATING SYSTEMS

To qualify for any off peak electric heating rate, the electric heat must be wired through a ripple control and turned off during load control periods. It is desirable to have all electric heat within a structure controlled, but electric heat in some rooms of a structure may be left uncontrolled and subject to regular rates if it is cost prohibitive to extend a backup heating system to the room. In no event may there be two or more in-room electric heaters in any room or open area that are not all controlled.

MULTIPLE LOAD CATEGORIES

In the event a Consumer has electric heat in multiple load categories wired through the same off peak meter, the applicable rate will be the highest assigned to any of the load categories. The Consumer could pay different rates for off peak electric heating in the same or different structures if their electric heat is controlled in different load control categories and metered separately.
