### Director nominations, petitions due March 4

Each year the terms of three of Red Lake Electric Cooperative's (RLEC) directors expire the day of the annual meeting. Members of each of the three districts whose terms of the present directors will expire April 3 have elected director candidates at the recently held district meetings.

The names of the candidates are Colette Kujava, Newfolden, District 3; Randy Versdahl, Red Lake Falls, District 6; and Peter Mosbeck, Red Lake Falls, District 9.

Their names will be placed in the nomination at the annual meeting. Any other member within these districts wishing to have their name placed in nomination must do so by petition. The petition is due in the RLEC office in Red Lake Falls by 10 a.m. March 4.

At least 15 members of the district must sign the petition for the director nominee. The nominee's name will then be placed on the election ballot at the annual meeting (6902018.07 Mikayla S. Tabert) April 3 at the Ralph Engelstad Arena in Thief River Falls.

## Red Lake Electric Cooperative Director qualification requirements

No member shall be eligible to become or remain a director who:

- Is not a member of the Cooperative and receiving electric service at the member's primary residence in the district from which the director is elected.
- Was an employee of the Cooperative within three years preceding a director candidate's nomination.
- Will be, is or at any time during the three (3) years preceding a director candidate's nomination was employed by a labor union, which represents or has represented, or has endeavored to represent any employees of the Cooperative.
- Is a parent, spouse or cohabitant of any employee of the Cooperative.
- Is a person who is a parent, spouse or cohabitant of an incumbent director who is not up for re-election at that time.
- Is in any way employed by or substantially financially interested in an enterprise competing with the Cooperative or any Cooperative-affiliated business.
- Is or becomes the full-time employee or agent of, or who is or becomes the full-time employer or principal of, another director.



### Area high school scholarships

Around this time each year, Red Lake Electric Cooperative (RLEC) mails out letters to area high school scholarship supervisors notifying them of the Red Lake Electric's scholarship program available to graduating seniors.

Since 1990, RLEC has awarded 309 scholarships totaling more than \$127,000. The majority of these scholarships are funded from unclaimed capital credits. If, after seven years, capital credit checks mailed out by RLEC to past members are not cashed, the state of Minnesota allows RLEC to donate these monies. Your Cooperative has decided to donate these monies as scholarships to graduating seniors who qualify as a RLEC member dependent.

Each scholarship awarded is valued at \$500. RLEC currently donates to 12 area high schools. If you have a senior planning to further their education, please encourage them to apply at their school for the Red Lake Electric scholarship.

### 81st annual meeting

We are planning your cooperative's 81st annual meeting, which is set for Wednesday, April 3, at the Ralph Englestad Arena in Thief River Falls. This will be our 14th consecutive annual meeting held in the Imperial Room at the arena. The annual meeting is a great time for you to ask questions and meet with the board of directors and staff. ### **Report from** the Office

### Meetings

The Red Lake Electric district meetings for 2019 are history. It was nice to see many of our members at these meetings. I enjoy visiting with you and hearing your comments and concerns. It is also an opportunity to actively participate in Cooperative Principle No. 2, democratic member control, by being able to nominate a member from your district to represent you on the Cooperative's board of directors. With the district meetings behind us, the focus now turns to the annual meeting ,which will be held April 3 in Thief River Falls.

### Capital credits

Your Red Lake Electric board of directors recently approved the payment of \$480,000 in capital credits. If you were a member in 2000 and are still a member receiving an electric bill from Red Lake Electric (RLEC), your portion of this payment will appear on the electric bill you receive in March. If you are a newer member, you may wonder what capital credits are. Capital credits reflect a member's ownership in the Cooperative. Simply put, capital credits are the amount of revenue left over at the end of the business year once all the

operating expenses have been paid. At the end of 2018, the Cooperative had margins (revenue minus expenses) of \$588,825. Being we are a not-for-profit cooperative, this amount will be divided between the 4,367 RLEC members based on how much each member paid for their electricity in 2018. This assignment of capital credits will remain in each member's account to be used by the Cooperative to build new or rebuild aging infrastructure, improve capacity and operate the Cooperative. Your Cooperative has an equity plan in place which guides the board in the annual evaluation of retiring capital credits to the membership. When a payout is approved by the board of directors, the oldest capital credits are paid back first. RLEC retires credits on a rotation which helps the co-op maintain an ideal equity level. If you have moved and no longer receive (3709010.02 Rosalie Leighton) an electric bill from RLEC, you will receive a check in March.

#### **Cherry Crumble**

## District meetings held in January

Three district meetings were held within Red Lake Electric Cooperative's (RLEC) service area at the beginning of February. Topics reviewed at the meetings included 2018 in review, Automated Meter Infrastructure (AMI) update, energy rebate incentives, website tutorial and available payment options.

In her manager's report, Stephanie Johnson discussed current year accomplishments as well as projects RLEC will work on in 2019. Current year discussion included energy sales, new service construction and safety. Looking ahead, the Cooperative will continue its work on replacing meters with automated metering infrastructure, which will consist of 7,500 new meters. RLEC is about 25 percent completed with this conversion.

Shirley Bregier, finance manager, gave a short tutorial of the Red Lake Electric website and payment options available to members. Bregier touched on the new online bill pay option, Smart Hub, which will be available in April.

In her report from member services, Kelli Brateng shared the many options available for electric heat and electric water heater rebate incentives. Brateng also informed members on the option to receive text or email notifications during load management periods. She also gave an update on the employee services available in the member service department.

The District 9 meeting was held the evening of Feb. 4 at Black River Lutheran Church, rural Red Lake Falls. Cooperative members in attendance unanimously elected Peter Mosbeck, the incumbent director, as the director candidate from the district.

The District 3 meeting was held Feb. 5 at Newfolden Community Center, Newfolden. Colette Kujava was unanimously elected (7525004.02 Shawn A. Qualley) as the director candidate of the district.

The District 6 meeting was held Feb. 6 at Terrebonne Town Hall, rural Red Lake Falls. Incumbent director Randy Versdahl was unanimously elected as the director candidate of the district.

A total of 63 members and friends attended the three meetings. Door prizes were awarded and refreshments were served.




**Energy Efficiency Tip of the Month**

Most space heaters are 1500 watts. If you're operating a space heater eight hours a day and your rate is 10.2 cents per kWh = (1500 watts x 240 hours/month) / 1000 = \$36.72/month

### **Operation Round Up® grant** applications due March 6

rganizations involved in community projects and charities are encouraged to apply for funds from Operation Round Up. Completed grant applications are due in the Red Lake Electric Cooperative (RLEC) office by Wednesday, March 6.

Operation Round Up is a program adopted by RLEC, headquartered in Red Lake Falls. Members choosing to "round up" their monthly electric bill payment provide funds for this effort. Today 96 percent of RLEC members now choose to contribute pennies each month to enhance their communities.

Funds will be donated primarily to nonprofit organizations to help fund specific projects or programs. Since the program began in 1993, \$538,266 has been granted to community organizations and charities. Money is donated for the betterment of the community within the outside

service area boundaries of RLEC.

The Red Lake Electric Trust Board of Directors determines grants. Board members are Julie Stennes, Thief River Falls; Tishara Melcher, Middle River; Diane Kolstoe, Oklee; Stephanie Johnson, Gatzke; and Bonnie Christians, Crookston.

To apply for Operation Round Up grants, organizations should contact the RLEC office in Red Lake Falls at 218-253-2168 or 800-245-6068. A short application must be completed and submitted along with (5313001.08 Mike Stickler) a financial statement from the organization.






Through the Infinity Renewable Energy program, you can decide how much of the electricity you purchase is generated by renewable resources.

Provides the highest efficiency for space heating and cooling available today. The system transfers heat to and from the earth using only small amounts of electricity.

Closed loop: Rebate of \$400 per ton Open loop: Rebate of \$200 per ton

☐ Electric underfloor boiler

A popular off-peak option because the system transfers consistently across the floor to reach people and objects, providing both comfort and efficiency. Applications include electric boiler with hydronic tubing.
